Chief's Report

Training and Seminars

- ISEP 200 Course – Cohort #3 – Three members of Patrols
Purpose: Investigator Level Two course sponsored by the AB Solicitor General
- Senior Technician Course – Intoximeter EC/IR II – Two members of Traffic Response Unit
Purpose: Upgraded certification on Intoximeters.
- In Service TACT, K9, Note Taking and Court Testimony training will occur this month.

Human Resources Update

- On 6 January 2010 6 new inexperienced members were sworn in. They begin basic recruit training on January 11, 2010 here in Medicine Hat.

Activity Update

- Facility Upgrade: Two members of our project team attended a new police facility located in Kingston Ontario that Rebanks Pepper Littlewood Architects Inc. have designed and built to make note of best practices for facilities similar in size.
- On January 8 the executive team met to discuss and finalize changes as communicated in the business plan.
- The year end variance report is favorable. A healthy positive variance is expected and will be reported on at meeting date.

Operational Services

Specialized Traffic Enforcement Unit

- Safety messaging trailer was only deployed twice during month of December due to amount of snow and poor road conditions.
- Implementation of new equipment postponed to February based on availability of vendor to conduct training.

Traffic Unit

- Operation Care and Control concluded at the end of December. The results were:
 - 35 Impaired Driving charges
 - 7 – 24hrs suspensions
- Service assisted Canadian Military at Suffield and conducted laser/radar training.
- Traffic unit and MADD conducted three impaired driving check stops in the month of December.
- Cst. Brian Bohrn conducted 18 CVSA Level I commercial vehicle inspections with the Department of Transportation at the weigh scales as part of his training.
- A total of 431 MVC's were reported in the month of December, another poor year end due to weather and road conditions.

Bylaw Section

- Section received 490 calls for service, of those 109 (22%) were officer initiated.
- Two aggressive dog complaints in the month resulting in three charges.
- 71 complaints in relation to lack of snow removal, 52 warnings given and 7 charges.
- 96 animal control complaints, lowest in two years, attributed to weather.
- There were 800 document service attempts, 55% over Dec 08.

Community Resource Unit

- Unit partnered with the AMA on a Theft from Motor Vehicle initiative. The objective of program to raise public awareness and reduce theft from vehicles and involved the creation of 2500 placards to be placed in vehicles that were unlocked. The cards reminded the public to secure items out of sight and to lock the doors.
 - 540 vehicles were checked at various large shopping centers throughout the city;
 - 128 vehicles found insecure, all with valuables inside;
 - 200 individuals approached and spoken to by police.
 - Appeared to be well received by community.

Support Services

Major Crimes Section (MCS)

- On December 23, 2009, an armed male wearing a disguise walked into Pharmasave and demanded narcotics from the pharmacist. The suspect is described as a white male, 5'7 to 6' ft tall, weighing 170-180 lbs at 20-30 years old. The suspects description and the MO of the robbery are similar to a robbery that occurred at the Crestwood Pharmacy on Oct 29th, 2009. Members of the MCS continue to investigate.
- On January 3, 2010 around 8 AM, two unknown persons kicked in the door of a residence in the 400 block of 12th Street SE. The two masked suspects brandished weapons, assaulted the occupants of the residence, then left in the one of the victim's vehicles. The stolen vehicle was recovered a short time later several blocks away. At this time it appears that the motivation for the home invasion/robbery was monetary. The two victims were treated and released from hospital. MCS continue to investigate.
- On January 3, 2010 a lone female entered the Crescent Heights IDA Pharmacy on 8 St NW armed with a knife and wearing a disguise. The suspect stole various narcotics then fled. Police were able to determine the identity and location of the suspect. Search warrants were executed which lead to the recovery of the narcotics as well as the clothing worn by the suspect during the robbery. A 21-year-old female is facing various robbery related charges. In addition, a 45-year-old male is facing charges of possession for the purpose of trafficking and bail violations.
- On January 4, 2010 the Gas Plus at 1740 Gershaw Dr SW. was robbed by an armed female. The female suspect is described as: white, u/k age, 5'7, with dark wavy hair, wearing a black hoodie pulled up over her head, cargo pants, and white gloves. The suspect fled with a small amount of cash and property into a waiting vehicle driving by a second person. No further descriptions were available. MCS continues to investigate.

Organized Crime Section (OCS)

- A lot of time was spent during December conducting training with the new CFSEU members who arrived from the RCMP. CFSEU will continue to train to ensure the new members are current.
- CFSEU concluded a minor project where undercover purchases of marijuana were made from a Medicine Hat man. A CDSA search warrant was executed and a small amount of marijuana, packaging material, scales, score sheets and cash was recovered. CFSEU/MHIIU executed two residential CDSA search warrants at two Medicine Hat residences involving large scale marijuana grows. At the first residence, CFSEU discovered a sophisticated 3 stage grow where 450 plants were recently "clipped" (harvested) leaving behind the stems, which in some instances were 3-4 feet tall. In the other residence there were approximately 240 mature cannabis marijuana plants ready to be cropped out. No arrests have been made to date. Nearly \$600,000 street value of marijuana was seized.
- At the end of December, CFSEU/MHIIU concluded an investigation that focused on a group who were distributing both cannabis marijuana and cocaine in Medicine Hat. A number of search warrants were executed and four Medicine Hat residents

have been charged with various CDSA related offences. The investigation netted nearly 3 kilos of marihuana and close to 3 ounces of cocaine with a combined street value of over \$41,000. Also seized from a residence was a prohibited 9 mm handgun and ammunition. Firearms charges were also laid.

Forensic Identification Unit:

- FIU members attended 86 calls for service through the month of December and up to January 4, 2010 involving violent home invasions, armed robberies, fires/arsons, injury mvc's, several stolen autos, hit & runs, numerous assaults, sudden deaths, break & enters and DNA orders/ warrants.
- FIU members continue to utilize their skill sets and support investigational units by assisting in identifying crime suspects through the development of composite drawings, fingerprint and footwear comparisons, etc.
- The implementation of the 2010-1012 Business Plan, specifically additional resources for FIU/Exhibit control, is greatly anticipated by the unit. Demands continue to outpace capacity.

Police Information Coordination:

- During 2009 the Police Service saw a trend by agencies such as Alberta Health, and to a lesser degree the Medicine Hat College, who began to obtain required security checks through the use of private companies. The RCMP has since refused these private companies access to vulnerable sector searches through CPIC. This recent restriction has shown increased local requests from both Alberta Health and MHC. CPIC will be meeting with Police reps from each province on January 19, 2010 to discuss issues and guidelines concerning police background checks.
- In addition to the cash totals highlighted in the following stats, approximately \$7,000 more was invoiced to various city organizations in 2009.

API-3 Update

- Service Alberta has drafted the Vendor contract and it is being reviewed by API3 staff. Once the contract is signed, the Sierra Project Team and the API3 team will meet for planning sessions to establish the work plans.
- The construction of the API3 office, which will house the servers and API3 staff, has been delayed by Alberta Infrastructure. This construction will impact the pilot project in Calgary by delaying it until March 1, 2011. Alberta Infrastructure has agreed to a 24/7 work schedule to attempt to reclaim the lost time.

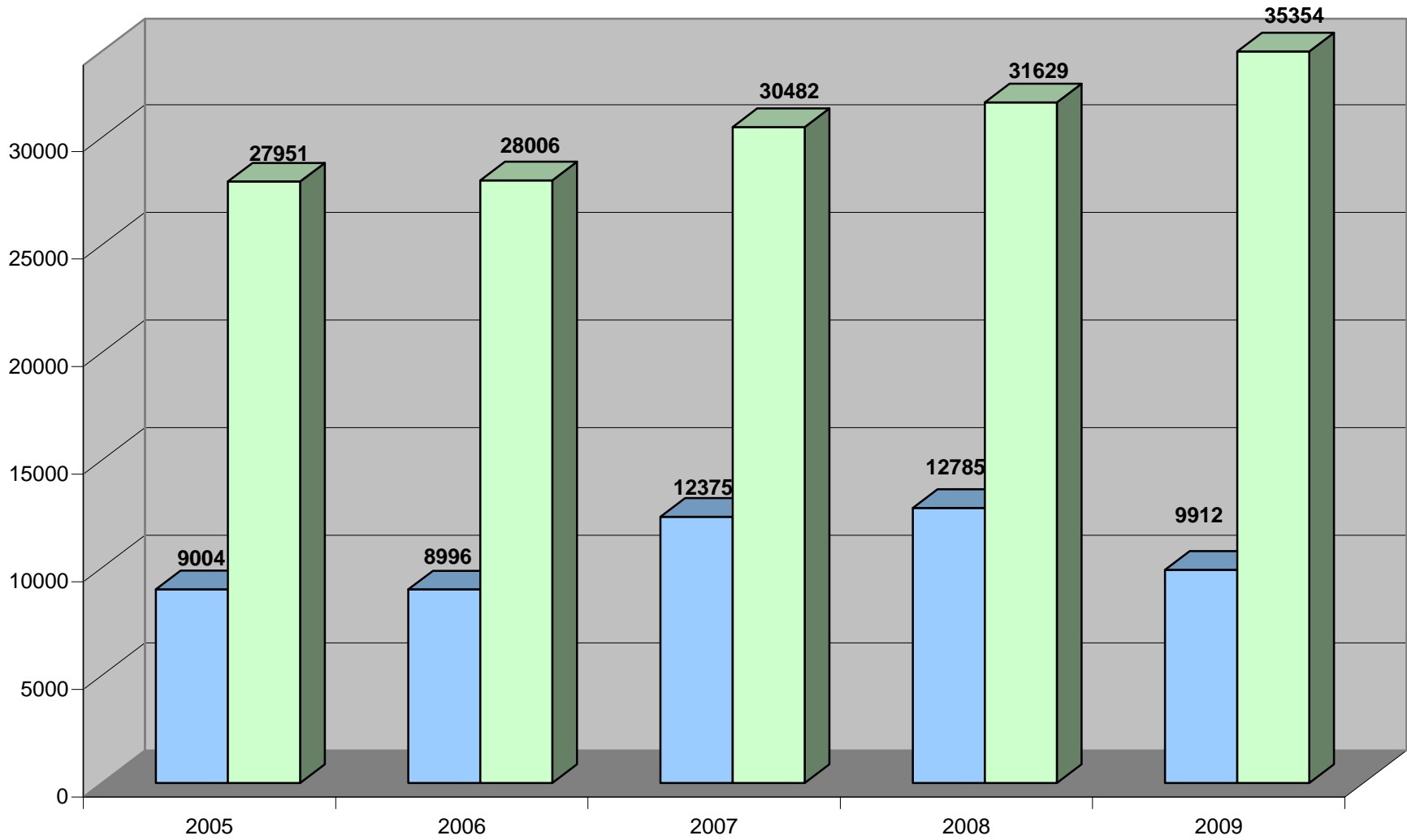
Statistical Update:

Current MHPC Policies and Procedures

Chapter B Section 22

Procedure for Presentations to the Police Commission

1. When an individual or group contacts any member of the Police Commission requesting to appear before the Commission at a meeting, the Commission member must forward the request to the secretary of the Commission as soon as is practicable.
2. The individual or group requesting to appear before the Commission shall be contacted by the Police Service and asked to put their presentation in writing and forward it to the Chairperson.
3. Information received from the individual or group will be included in the information package sent to all Commission members prior to the meeting.
4. The individual or group shall be given information pertaining to the date, time and location of the next Commission meeting, as well as arrangements made to meet and escort them to the Police Services Board Room.
5. The Chairperson of the Commission shall indicate whether he or she wants this presentation to be presented in an open or closed Commission meeting.
6. At a meeting, the Commission may, by two-thirds (2/3) majority vote, agree to hear a member of the public on an issue not on the agenda.

Suggested Change:

Chapter B Section 22

Procedure for Presentations to the Police Commission

1. The Police Commission's responsibilities are outlined under Section 31 of the Police Act. The Police Commission may make inquiry of the police service through the Chief of Police relating to activities of the Police Service.
2. The Police Commission may make inquiry on behalf of the community. As such the Police Commission may receive inquiry from members of the community in two ways:
 - a) Written correspondence addressed to the chair of the Police Commission.
 - b) Verbal inquiry or presentation at an open Police Commission meeting.
 - i. All verbal inquiries or presentations at open meetings will be no longer than five minutes.

- ii. Only one question may be asked and one follow-up question is permitted should further clarification be required.
- 3. The Police Commission chair will hear any questions and determine:
 - a) If the question can be answered by a member of the Commission or the Chief of Police.
 - b) If the question should be deferred to gather more information.
 - i. Should the question be deferred and a response will be directed to the individual or group posing the question.
